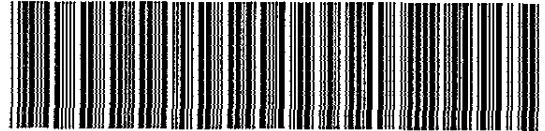

Pursuant to and in compliance with Chapter 617.0202, F.S. these articles of incorporation are set forth:

Article I:

The name of the corporation shall be: Holy Spirit Ecumenical Catholic Church, Inc.

Article II:

The principal place of business of this corporation shall be:

The mailing address of this corporation shall be:

Article III:

The specific purpose for which the corporation is organized is to establish and maintain an independent Catholic community of faith through its worship services, education programs, social outreach to the needy and parish social events.

The mission statement of the corporation is:

We, the Community of Holy Spirit Ecumenical Catholic Church,
believe that all people are created in the image of God
and are unconditionally loved by God.

All persons are free to enjoy God's gifts of love, joy and intimacy.

We are determined that our life together will be fully inclusive.

We strive in our words and actions

and to act as full participants
in the life, membership and leadership of this church.

Hearing God's word and strengthened by the Eucharist,

we commit ourselves anew to live and share our faith boldly

Article IV:

The manner in which the directors (a.k.a. parish councilors) are elected:
The names of the candidates for parish council are submitted by registered parishioners to the vice-chair thirty (30) days prior to the appointed election date. Each registered adult parishioner receives one ballot to cast in the election. The candidate receiving the simple majority is to be considered elected to the parish council for the given office. The term shall be one year, renewable once.
