#### ARTICLES OF INCORPORATION

#### of FORE YOUTH, INC.

(Fulfilling Opportunities through Recreation & Education)

FORE Youth, Inc., the undersigned incorporator, for the purpose of forming a corporation under the Florida Not for Profit Corporation Act, hereby adopts the following Articles of Incorporation:

#### ARTICLE I. NAME

The name of the corporation shall be FORE Youth, Inc.

#### ARTICLE II. PRINCIPAL OFFICE

#### ARTICLE III. PURPOSE

FORE Youth, Inc is organized for charitable and educational purposes under section 501 (c) (3) of the Internal Revenue Code.

#### ARTICLE IV. MANNER OF ELECTION OF BOARD OF DIRECTORS

The Board of Directors shall range from a minimum of 3 to a maximum of 11, such maximum which can be changed pursuant to the by-laws of the corporation. #### ARTICLE V. LIMITATIONS

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article III hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, nor shall the corporation participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a). by a corporation exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b), by a corporation, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

#### ARTICLE VI. DISSOLUTION

Upon dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for public purpose.
