# **ARTICLES OF INCORPORATION**

**(Not For Profit)**

## **Article I Name**

The Name of the Corporation (Ministry) shall be:

**YAH HOUSE OF WINE/TINA CLEMENS MINISTRIES, INC.**

## **Article II**

The principal place of business and mailing address of the corporation is:

## **Article III**

The specific purposes for which this corporation is organized are:

1. To preach and teach the word of YHWH (GOD).
2. To assemble together people for seminars, worship services and cultural and performing Arts demonstrations.

### **ADMINISTRATION**

**(Directors)**

- E. No person shall serve, nor continue to serve, as a member of the Board of Directors who does not subscribe to the purposes of this ministry as set forth in Article 3 of these articles of incorporation.

The officers shall consist of a President, a Vice-President, a Secretary, a Treasurer, and such additional officers as may be deemed necessary and appointed or elected by the Board of Directors. The duties of each officer shall be as provided in the by-laws.

Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by:

1. A corporation exempt from Federal income tax under section 501 (c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law or,
2. A corporation contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code of 1986 or any other corresponding provision of any future United States Internal Revenue Law.
