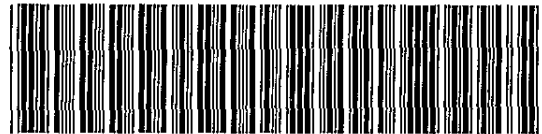

## **ARTICLES OF INCORPORATION**

In Compliance with Chapter 617 F.S., (Not for Profit)

### **ARTICLE I NAME**

The name of the corporation shall be:

The Name of the corporation shall be **CentsOfRelief.org, Inc.** hereafter referred to as the "Corporation."

### **ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be:

The Corporation's principle office and mailing address shall be 428 Merlin Way, 32301 Tallahassee, Florida or such other location as the Board of Directors may from time to time determine. The Corporation shall maintain within the State of Florida a registered office at such place, which may be the principle office, as the Board of Directors may from time to time determine.

### **ARTICLE III PURPOSE**

The purpose for which the corporation is organized is:

To be organized and operated exclusively for educational, charitable, and/or religious purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, as amended (or to any corresponding provision of any future tax law), (the "Code"), as follows:

- 1) To provide assistance to not-for-profit and governmental organizations in India and other countries outside the U.S. that give support to children who have lost one or both parents to AIDS and support Women who have been victimized by the Sex trafficking in India.
- 2) To engage in fundraising for the purpose of providing assistance to the abovementioned activities.
- 3) To provide assistance to governmental and not-for-profit organizations in and outside the U.S. with purposes similar to, or with the activities in furtherance of, the purposes set forth hereinabove.
- 4) To engage, subject to the foregoing limitation and those set forth below, in any lawful act or activity for which a corporation may be organized under the Florida Non-profit Corporation laws.

CentsofRelief.org, Inc. endeavors to combat the AIDS epidemic in India by raising awareness/education among the youth, helping to improve existing counseling/psychosocial centers for adults and orphans, and promoting scientific research on AIDS. All proceeds raised by our organization will be allocated equally among the organizations focused on those missions. Also sponsors will sponsor the sites visitors "clicks" on a specific image of the web page, which will be allocated to help the HIV/AIDS epidemic in India.

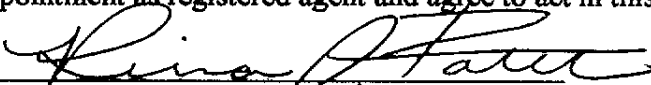
