ARTICLES OF INCORPORATION

Articles of Incorporation of Global Evangelistic Network, INC.

KNOW ALL MEN BY THESE PRESENT:

That the Global Evangelistic Network, Inc., a voluntary association, and the members of said church have voluntarily associated themselves to form a non-profit Corporation under the laws of the State of Florida and we hereby certify:

**ARTICLE I:** The name of this corporation shall be: Global Evangelistic Network, Inc., 2640 Old Bainbridge Road, Tallahassee, Florida 32303, in Leon County in the State of Florida, with mailing address: 2184 Gates Drive, Tallahassee, Florida 32312.

**ARTICLE II:** That the County of Leon, in the State of Florida is the county where the principal office for the transaction of business for this Corporation is to be located.

**ARTICLE III:** That the primary purpose for which this Corporation is formed is to: cultivate, promote, promulgate, and extend the teaching, precepts, practices and discipline of the church Christ established after His resurrection, and to conduct and maintain a Christ Network to strengthen the Community through various programs that will add to a more stable society.

This requirement shall not be deemed to preclude a statement of General Purpose or power or to restrict the right of the Corporation to engage in other lawful activity.

- To act as Trustee under any condition incidental to the principal subject of the Corporation, and to receive, hold, administer and extend funds or property subject to such trust;
- To convey, exchange, lease, mortgage, encumber, transfer upon trust, or otherwise dispose of all property, real or personal;
- To borrow money, contract debts and issue bonds, notes, debentures, and secure same;
- To contract and be contracted with;

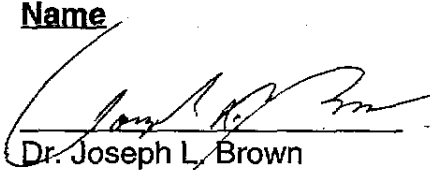
- To do all acts necessary or expedient for the administration of the affairs and attainment of purpose of the corporation;
- That the Corporation is organized pursuant to general Non-Profit law;
- That the Corporation is a corporation that does not contemplate pecuniary gain or profit to the members thereof;
- Any two members of the Board of Trustees (directors), along with the Chairman of the Corporation (for a total of three individuals) are authorized to sign documents Contractual of otherwise) on behalf of the full Corporation. The Chairman signature is required on all contractual documents as the third (3<sup>rd</sup>) signature.
- 501-C-3 Dissolution Status For the Disbursement of Assets:  
Upon dissolution of this corporation/organization assets shall be distributed for one or more exempt purposes within the meaning of SECTION 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future Federal tax code or shall be distributed to the Federal government, or to a state or local government, for a public purpose.

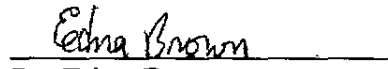
Global Evangelistic Network, Inc. is organized exclusively for religious and charitable purposes, including such purposes, the making of distributions to organizations under Section 501 (c) (3) of the Internal Revenue Code (or the corresponding section of any future Federal Tax Code.)

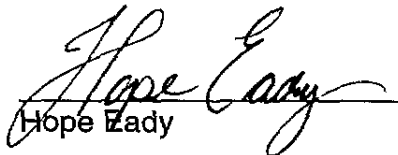
No part of the net earnings of the corporation/organization shall inure to the benefit of or be distributable to its members, trustees, directors, officers or other private person, except that the corporation/organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of Section 501 (c) (3) purposes. No substantial part of activities of the corporation/organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation/organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.

**ARTICLE IV:** Directors who shall be given the title Trustees shall be decided upon in an annual meeting in January. Elections shall be by ballot, subject to the approval of the Election Board before such election is confirmed. Each candidate must qualify according to Network by-laws to serve in a leadership role. If a vacancy occurs in the Board of Trustees, the remaining trustees shall submit to the Election Board for approval, the name of some person to fulfill the unexpired term until the next meeting.

**ARTICLE V:** The undersigned incorporates have executed these Articles of Incorporation this 18<sup>th</sup> day of June, 2003.

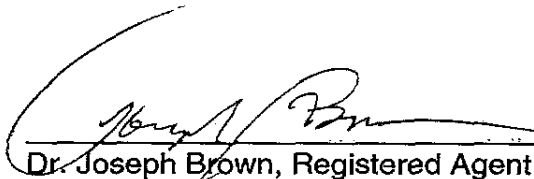

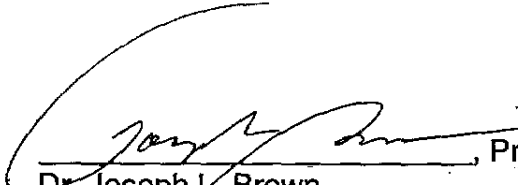

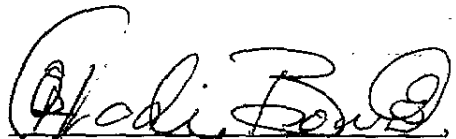
