

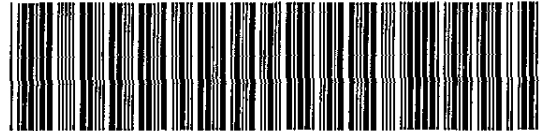

ARTICLE III - PURPOSE

Ministry through God: the Father, Son and Holy Spirit: praise, worship, prayer, preaching, teaching, baptism, divine healing, music, edification, counseling, marriage & burial ceremonies, aid & health support, assistance, appeals, housing, emergency shelter, food, clothing, supplies, transportation, education, workshops, retreats, missions, prophesy, recordings, tapings, filming, travel, referral system(s), coordination of services and/or any way in which the Holy Spirit leads us to minister, etc. Pastoral retreats, counseling, help, support, and/or comfort for religious/spiritual leaders, and/or others of the body of Christ, etc. Raise and/or train animals to assist the physically, mentally and/or emotionally challenged persons or others in need. Sheltering of animals for training, work, placements, associations, outings, etc. Provide, educate, place and/or associate individual(s) or groups with animal(s) for companionship, service, aid, protection, etc. Teach and/or assist individuals to understand the capacity of the animal(s) to help assist them to increase independent living, etc. Parenting education for divorcing & divorced parents & guardians, etc. Counseling & educating children of divorce or separation, etc. Anger management, counseling & education for adults. Mediation for conflict resolution. Professional advice or referral, etc. Guardian Ad Litem for children's safety and/or supervision of visitations. Family services and/or education, communications, etc. Help youth & adults of substance abuse, addictions and/or other problems through 12-step program and/or other methods, etc. Physical, mental, emotional and/or spiritual enrichment through art and/or artistic venues, etc.
