The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

ARTICLE I: NAME

The name of the corporation is Floridians for constitutional Integrity, Inc.

ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 3212 Northwest 58th Boulevard, Gainesville, Florida 32606.

ARTICLE III: PURPOSE
