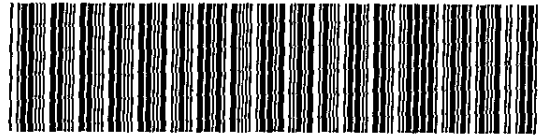

ARTICLE I NAME

The name of the Corporation shall be **Southeast Football League, Inc.**

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

The purpose for which the corporation is organized is: To form an organization of teams that all have the same agenda of providing athletes with a place to play, the opportunity to cultivate and improve their football skills and giving them; (1) a second chance of an education at an institute of higher learning, (2) fulfilling their football aspirations by attracting scouts from the collegiate and professional levels, and/or, (3) offering them a safe place to meet and cultivate new friends.

ARTICLE IV MANNER OF ELECTION

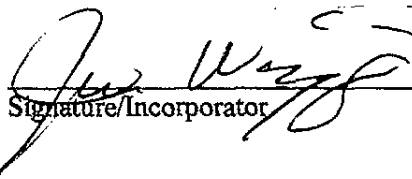
