ARTICLES OF INCORPORATION

Article I, Name

The name of this Florida not-for-profit corporation is: The Loan Committee Inc.

Article II. Address

Article III. Purpose

The Corporation is organized exclusively to engage in all lawful acts or activities for which Florida not-for-profit corporations may be organized, including one or more of the following purposes: business league, chamber of commerce, real estate board, or board of trade pursuant to Internal Revenue Code Section 501(c)(6), as amended or to corresponding provisions of future federal tax legislation.
