**ARTICLES OF INCORPORATION**

The undersigned, acting as incorporator to form and establish a corporation **NOT FOR PROFIT** pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation for such corporation:

**ARTICLE I**

The name of the corporation is: Southeast Group Home, Inc. and the initial principal address of the corporation is: 175 Fontainebleau Blvd. Suite 2J-1A, Miami, Florida 33172

**ARTICLE II**

This corporation is to exist perpetually unless dissolved according to law. Corporate duration existence shall commence on June 27, 2003.

**ARTICLE III**

The purpose of this corporation is to provide support and services to individuals with a dual diagnosis of developmental disabilities and mental health issues. These services will be provided in residential settings as well as community integrated settings

**ARTICLE IV**

The corporation will chose it's board members based on their experience, interest, and knowledge of persons with disabilities. The members of the board will be representative of our diverse community and will be nominated by clients or other individuals associated with this agency, the nominees will then be voted upon secret ballot. The current members were nominated and chosen after meeting with current and potential clients of this corporation, this is an interim board and as the corporation grows the board will select and add members.

**ARTICLE V**

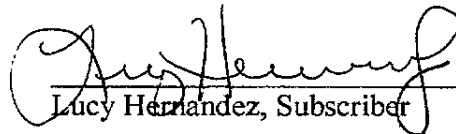
