The WinStar Foundation has been established to provide relevant, usable skills and perspectives to coaches in various sports that do not have the ability to acquire financial and/or mentor support. Its goal is to raise scholarship funds to host training sessions, work with the NCAA defining curriculum and create and opportunity zone that enables disenfranchised coaches to excel. The Foundation will establish several coaching tracks and Academies, based on the requirements, to reach a wide range of students. It will as well, establish a scholarship fund that allows graduates to mentor other students.

The Winstar Foundation is being established as a Not for Profit organization to allow its contributors to receive tax credit for helping less fortunate teachers gain skills and grow in their career.
