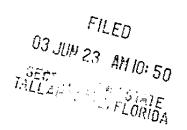

#### ARTICLES OF INCORPORATION

OF

### UNIVERSAL RHYTHM THE BAND INC.

(A FLORIDA NON PROFIT CORPORATION)



I, the undersigned, being a natural person, competent to contract, and acting as an incorporator, do hereby subscribe to the following Articles of Incorporation for the purpose of creating a Not-for-profit Corporation under Florida Statute 617.

#### ARTICLE 1 – CORPORATE NAME

The name of the corporation is: UNIVERSAL RHYTHM THE BAND INC.

#### ARTICLE 11 - DURATION

The duration of the Corporation is perpetual.

#### ARTICLE 111 – LOCATION

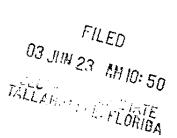
