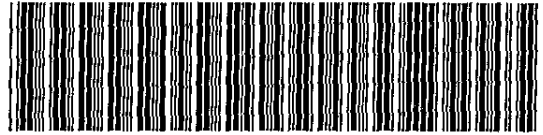

**Articles of Incorporation of
KING DAVIS CONGRESSIONAL COMMITTEE, INC.**

In compliance with Chapter 617, F.S., (Not for Profit)

IT IS HEREBY CERTIFIED THAT :

(1) The name of the proposed corporation is KING DAVIS CONGRESSIONAL COMMITTEE, INC.

(2) The purpose or purposes for which this corporation is formed, are as follows, to wit:
To engage in any lawful act or activity for which corporations may be organized in compliance with Chapter 617, Florida Statutes (F.S.). The corporation is not formed to engage in any act or activity requiring the consent or approval of any state official, department, board, agency, or other body.

The corporation, in furtherance of its corporate purposes above set forth, shall have all of the powers enumerated in Chapter 617 of the Florida Statutes, subject to any limitations provided in Chapter 617 or any other statute of the State of Florida.

(4) The Directors and Officers of this corporation shall be appointed by the Candidate of this corporation.

(i) liability if a judgment or other final adjudication adverse to a director or officer establishes that his or her acts or omissions were in bad faith or involved intentional misconduct or a knowing violation of law or that the director or officer personally gained in fact a financial profit or other advantage to which he or she was not legally entitled or that the director's or officer's acts violated Chapter 617, F.S. or

(ii) liability for any act or omission prior to the adoption of this provision.

(7) The Candidate, Kingsley D. Davis, is designated as the Registered Agent of the corporation upon whom process against it may be served at the address
