In addition, the Corporation shall not, during any period and to the extent it is a pri ate foundation described in section 509 of the Internal Revenue Code, (a) agage in any act of self-dealing; (b) retain any excess business holdings; (c) make any investments in a manner as to subject the corporation to tax under section 4944 of the Internal Revenue Code; or (d) make any taxable expenditure as defined in section 4945(d) of the Internal Revenue Code.

ARTICLE VI

The corporation shall be perpetual. Upon the dissolution of this nonprofit corporation essets shall be distributed for one or more exampt purposes within the meaning of section 501(c)(3) of the Internal Revenue code or corresponding section of any future Pederal tex o ie, or shall be distributed to the Federal government or to a state or lot I government for a public purpose. Any such assets not so disposed of shall a disposed of by a court of
