**ARTICLES OF INCORPORATION
OF
MARY ROMANO MINISTRIES, INC.**

The undersigned person, acting as incorporator of a corporation not-for-profit under the Florida Not-For-Profit Corporation Act, as set forth in Chapter 617 of the *Florida Statutes*, hereby adopts the following Articles of Incorporation for such corporation:

**ARTICLE I
Name**

The name of the corporation is **MARY ROMANO MINISTRIES, INC.**

**ARTICLE II
Principal Office and Mailing Address**

The street address and mailing address of the principal office is **1776 Roscoe Turner Trail, Port Orange, Florida 32128** and **P.O. Box 1648 Taylor Road #253, Port Orange, Florida 32128.**

**ARTICLE III
Purpose for which the Corporation is Formed**

This corporation is a not-for-profit corporation. This corporation is organized exclusively for charitable purposes within the meaning of section 501(c)(3) of the Internal Revenue Code. Specifically, this corporation is organized for religious purposes.

**ARTICLE IV
Dissolution**

Upon the dissolution or winding up of this corporation, its assets remaining after payment, or provision for payment, of all debts and liabilities of the corporation, shall be distributed to a not-for-profit fund, foundation, or corporation which: a) is organized and operated as an allowable not-for-profit corporation for charitable purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law; and b) has established its tax exempt status under Section 501(c)(3) of the Internal Revenue Code of 1986, or the corresponding provisions of any subsequent federal tax laws.

**ARTICLE V
Registered Agent and Office**

**ARTICLE VI
Incorporator**

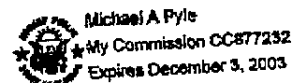
