ARTICLE I. NAME

The name of the Corporation shall be Mind Over Matter, Inc.

ARTICLE II. AUTHORITY

The corporation is organized pursuant the Florida Nonprofit Corporation Code.

ARTICLE III. INITIAL OFFICE AND AGENT

The street address of the initial registered office of the corporation is 8713 Catbriar Bay Way, Orlando, Florida 32829, and the initial registered agent at such address is Voltaire E. Nunez.

ARTICLE IV. PURPOSE

The corporation is organized exclusively for religious, educational, religious psychological counseling purposes, as well as to buy, purpose, own, acquire, by gift, devise, or otherwise, real and personal property, and to build, elect, construct, provide for, maintain and equip suitable buildings or other structures for the benefit, and use and occupation of the said and its associated member offices. To maintain and foster

Christian counseling and religious education training. To build, construct, erect, maintain and equip offices and classrooms, and such other facilities or equipment as the Center requires for carrying on its work.

To receive, administer, disburse and invest gifts, grants, devises, and bequests by or from any person or corporation.

To issue notes, debentures and evidences of indebtedness, and to secure the same by mortgage, deed of trust or otherwise.

This corporation is organized for the purpose of holding the title to such property or properties as the said Mind Over Matter, Inc., 8713 Catbriar Bay Way, Orlando, Florida 32829, shall from time to time, purchase or acquire, and it shall have power, from time to time, to make such contracts and to do such things as shall be authorized and directed by the Board of Directors and its advisors of the said Mind Over Matter, Inc., 8713 Catbriar Bay Way, Orlando, Florida 32829, evidenced by resolution of said Board.

To do everything necessary, suitable or proper for the accomplishment, attainment or furtherance of (and to do every other act or thing incidental to, pertinent to growing out of or connected with) the purposes, objects or powers set forth in these articles of incorporation, whether alone or in association with others; to possess all the rights powers and privileges now or hereafter conferred by law upon a nonprofit corporation organized under the laws of the State of Florida, and in general, to carry on any activities and to do any of the things herein set forth to the same extent as a natural person or partnership might or could do; provided that any purpose, object or power to do any act or thing forbidden by the law to a nonprofit corporation organized under the laws of the State of Florida.

ARTICLE V. DURATION

The corporation shall have perpetual duration.

ARTICLE VII. DISSOLUTION
