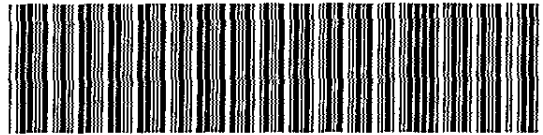

The undersigned incorporator(s), in order to form a not-for-profit corporation under the provisions of Chapter 617 of the Florida Statutes, hereby adopt the following Articles Of Incorporation:

ARTICLE I – NAME

The name of the corporation is P.O.W.E.R. Ministries, INC.

ARTICLE II – PRINCIPAL OFFICE

ARTICLE III – DURATION
