ARTICLES OF INCORPORATION

In compliance with Chapter 617, F.S., (Not for Profit)

OF



UNLEAVENED BREAD MINISTRIES, INTERNATIONAL, INC.

The undersigned, in order to form a corporate entity adopts the following articles of incorporation in corporation pursuant to chapter 617, Florida Statutes, adopts the following Articles of Incorporation:

ARTICLE (I) NAME

The name of the corporation shall be: UNLEAVENED BREAD MINISTRIES, INTERNATIONAL, INC.

ARTICLE (II) PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 4502 Evers Place, Orlando, Florida, 32811.

ARTICLE (III) PURPOSES

This corporation is organized exclusively for religious, charitable, and educational purposes. This is a ministry that will minister to the whole person; spiritually, physically, emotionally, socially and economically. We will provide different avenues of outreach through programs that will reach men, women, boys and girls, more specifically to encourage, educate and motivate productive living through the principles that are taught through the Holy Bible. UNLEAVENED BREAD MINISTRIES INTERNATIONAL, INCORPORATED will umbrella the following axillaries, ministries or outreach services. They are at current;

- (1) W.O.R.D. MINISTRIES (Women Of Royal Destiny) Local and International Meetings with groups of women to help and encourage them in a positive, purposeful lifestyle with Christ as their Lord. This will also be a ministry that will network with other ministries to promote unity and strength to the body of Christ.
- (2) O².F.F. THE CHAIN (On Our Face First) Youth Out Reach Ministry "If my people, which are called by my name, shall humble themselves, and pray, and seek my face, and turn from their wicked ways; then will I hear from heaven, and will forgive their sin, and will heal their land." (KJV II Chronicles 7:14) This part of the ministry will focus on our youth. We will have inspirational, and educational rallies, meetings, conferences, workshops, training courses, drama and dance gatherings to help motivate, validate, and inspire them to be all that they dream is possible- and more- through mentoring and discipleship through Christian 0and positive role models who will use biblically founded teachings.

- (7) UNLEAVENED BREAD BIBLE INSTITUTE This part of the ministry will focus on educating and training anyone who has a desire to know God's word and how to apply it in practical daily living through well thought out and prepared studies that will increase every student who diligently seeks to learn and know God in a closer way. The Institute will also have courses of study for those who aspire to be leaders in their church and community or those who are called to individual ministries. The scriptures admonishes us to "Study to shew thyself approved unto God, a workman (in what ever area God has called one to labor) that needeth not to be ashamed, rightly dividing the word of truth. "(2 Tim 2:15 KJV)
- (8) C.L.A.I.M. (Christian Leadership Associations and Independent Ministries). Being fellow laborers of the Gospel...we will partner to help each other connect with other groups of women to inform or get information that will help us individually and collectively reach our goals. We will put on joint conference, workshops, training classes, and etc. to help educate and support women who are striving to accomplish their dreams but don't exactly what steps to take first.

These outreach ministries will target all humanity from every walk of life to encourage them towards their destiny as spiritually positive, physically healthy, emotionally strong and socially functional individuals. All funds, whether income or principal, and whether acquired by gift or contribution or otherwise, shall be devoted to said purposes.

ARTICLE (IV) EXEMPTION REQUIREMENTS

At all times shall the following operate as conditions restricting the operations and activities of the corporation:

- 1. The corporation shall not afford pecuniary gain, incidentally or otherwise to its members. No part of the net earnings of this corporation shall inure to the benefit of any member of the corporation, except that those who actively perform may by paid reasonable compensation for the nonprofit corporate purposes or services approved by the board of directors and rendered to or for the corporation affecting one or more of these purposes stated under Article III.
- 2. No substantial part of the activities of the corporation shall constitute the carrying on of propaganda or otherwise attempting to influence legislation, or any initiative or referendum before the public, and the corporation shall not participate in, or intervene in (including by publication or distribution of statements), any political campaign on behalf of, or in opposition to, any candidate for public office.
- 3. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986, as now enacted or hereafter amended.

ARTICLE (V) DURATION

The duration of the corporate existence shall be perpetual.

ARTICLE (VI) MANNER OF ELECTION

The manner in which the directors are elected or appointed:

The manner in which the directors are elected are as follows: Methods of election are as set forth in the bylaws of this corporation.

The management of the affairs of the corporation shall be vested in a Board of Directors, as defined in the corporation's bylaws. No Director shall have any right, title, or interest in or to any property of the corporation.

Members of the first Board of Directors shall serve until the first annual meeting, at which their successors, if any, are duly elected and qualified, or removed as provided in the bylaws.
