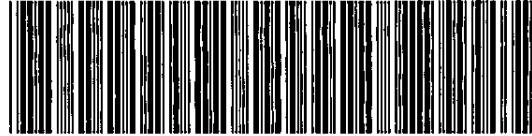

The effective date of the amendment set forth above is January 1, 2016.


ARTICLE IV. ADOPTION OF AMENDMENT
