# ARTICLES OF INCORPORATION OF

SECRETARY OF STATE FALLAHASSEE FLORIDA

# HILLSBOROUGH HIGH SCHOOL BAND BOOSTERS, INC. A Not-for-Profit Corporation

In compliance with the requirements of F.S. Chapter 617, the undersigned, being a natural person, does hereby act as incorporator in adopting and filing the following Articles of Incorporation for the purpose of organizing a business corporation.

### ARTICLE 1

The name of the corporation is HILLSBOROUGH HIGH SCHOOL BAND BOOSTERS, INC. ("Corporation").

## ARTICLE 2

The existence of the corporation shall begin immediately effective upon the acceptance of these Articles of Incorporation by the Florida Secretary of State.

#### ARTICLE 3

The purposes for which the corporation is organized are exclusively religious, charitable, scientific, literary and educational within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provisions of any future United States Internal Revenue law. This shall include the purpose of the corporation to be a not-for-profit corporation under Chapter 617, Florida Statutes, and to promote and support the band program at Hillsborough High School through fund raising, transportation and any other activity that would enhance and foster the band program, its members and Hillsborough High School.

Notwithstanding any other provisions of these articles, this organization shall not carry on any activities not permitted to be carried on by an organization exempt from Federal income tax under Section 501(c)(3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue law.

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of Section 501(c)(3) of the Internal Revenue Code of 1986, or corresponding section of any future Federal tax code, or shall be distributed to the Federal, state, or local government for a public purpose. Any such asset not so disposed of shall be disposed of by a court of competent jurisdiction of the county in which the principal officer of the organization is then located, exclusively for such purposes.

# **ARTICLE 4**

The address of the principal office of the Corporation is 5000 Central Ave., Tampa, FL 33603.

#### ARTICLE 5

The Corporation shall have a minimum of three (3) and a maximum of fifteen (15) members of the Board of Directors. The manner in which the members of the Board of Directors are elected or appointed shall be set forth in the Bylaws of the Corporation.

# ARTICLE 6

The initial street address of the Corporation's registered office is 5000 Central Ave., Tampa, FL 33603. The initial registered agent for the Corporation at that address is Kim Meider.

# ARTICLE 7

The name and street address of the person signing these Articles of Incorporation is Kim Meider, 5000 Central Ave., Tampa, FL 33603.

## **ARTICLE 8**

The Corporation shall indemnify its directors, officers, employees and agents to the fullest extent permitted by law.
