# ARTICLES OF INCORPORATION

The undersigned, for the purpose of forming a not for profit corporation under Chapter 617, Florida Statutes, does hereby adopt the following Articles of Incorporation:

#### ARTICLE I: NAME

The name of the corporation is Pensacola Auto Racing Association Radio Controlled, Inc.

#### ARTICLE II: PRINCIPAL OFFICE

The principal place of business and mailing address of the corporation is 5500 Cox Road, Milton, FL 32583.

#### ARTICLE III: PURPOSE
