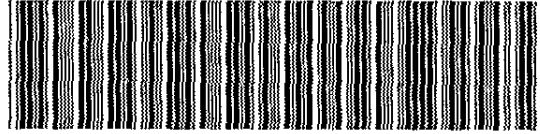

Pursuant to the provisions of sections 617.1006, Florida Statutes, this **Florida Not For Profit Corporation** adopts the following amendment(s) to its Articles of Incorporation:

**AMENDMENTS ADOPTED:**

The specific purposes of this Florida Not For Profit Corporation shall be to teach the Word Of God to those individuals desiring to learn more about the Bible. To provide understanding of the Bible in its origin, history, purpose and value.

This corporation is organized exclusively for charitable, educational, religious, and/or scientific purposes within the meaning of section 501(c) (3) of the Internal Revenue Code of 1986 (or corresponding section of any future Federal tax code). (added)

No part of the earning of the corporation shall inure to the benefit of, or be distributable to, its members, trustees, directors, officers, or other persons, except that the corporations shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c) (3) purposes. (added)

No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of, or in opposition to, any candidate for public office.  
(added)

Notwithstanding any other provision of these articles, the purposes and activities of the corporation shall be limited exclusively to exempt purposes and activities within the meaning of section 501(c) (3) of the Internal Revenue Code of 1986 (or corresponding section of any future Federal tax code). (added)

Upon dissolution of this corporation assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or shall be distributed to the Federal, State, or Local Government for a public purpose. (added)
