FLORIDA COUNCIL OF CHURCHES OF GOD 7TH DAY, INC.

ARTICLE VIII

Amending to add Article VIII: In Event of Dissolution.

Said organization and its property is organized and dedicated exclusively for religious and charitable purposes and no part of the net income or assets of the organization shall ever inure to the benefit of, or distributable any director, trustee, officer, or member thereof or the benefit of any private person, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause thereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office. Notwithstanding any other provision of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or (b) by any organization, contributions to which are deductible under section 170 (c) (2) of the Internal Revenue Code, or corresponding section of any future federal tax code.

On the dissolution or winding up of the corporation, its assets remaining after payment of, all debts and liabilities of this corporation, shall be distributed to one or more nonprofit funds, foundations, or corporations which is organized and operated exclusively for religious purposes and which has established its tax-exempt status under Section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
