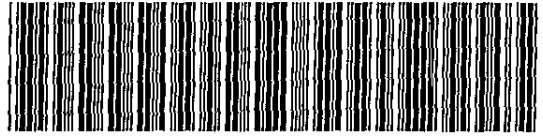

ARTICLES OF INCORPORATION

The undersigned, acting as incorporator(s) of a Corporation pursuant to Chapter 617, Florida Statutes, adopt(s) the following Articles of incorporation of such corporation:

ARTICLE I NAME

The name of the corporation shall be:

ARTICLE II PRINCIPAL OFFICE

ARTICLE III PURPOSE

The purpose (purposes) for which the corporation is organized is (are):

This corporation is a Not-For profit Corporation organized under chapters 617, Florida Statutes. It is not organized for private gain of any person, the specific purposes of this corporation are:

1. To promote the health, safety and welfare of the members;
2. To acquire, hold, rent, own and deal in both real estate and personal property.
3. To borrow, invest and lend money and use credit;
4. To enter contracts, and issue notes, bonds and other indebtedness papers;
5. To elect officers, directors and agents to define their duties and obligations to the corporation; and to compensate them for their services.
6. To make by laws that are to be used in the transaction of all lawful business activities.
7. To pay pension, retirement, benefits and other compensation plans.
8. The ability to sue, and or be sued, and to bring or defend against illegal causes of action.

ARTICLE IV MANNER OF ELECTION

The manner in which the directors are elected or appointed:

1. The Nominating Committee will select new Directors and present them to the General Assembly for elections. The Nominating Committee shall consist of the Senior Pastor and the Governing Board.
2. The term of office for all elected offices shall be for two (2) years.
3. The Nominating Committee shall publicly post their list of nominees two (2) weeks prior to the annual election of officers.


