ARTICLES OF INCORPORATION

A Nonprofit Corporation

Articles of Incorporation of the undersigned, a majority of whom are citizens of the United States, desiring to form a Non-Profit Corporation under the Non-Profit Corporation Law of FLOCIDES, do hereby certify:

Article 1: The name of the corporation shall be:

TRUE WAY MINISTRIES INTERNATIONED WE

Article 2: The Place in this state where the principal office of the Corporation is to be initially located is the City of <u>SACKSONVILLE</u>, <u>DWITL</u> County.
