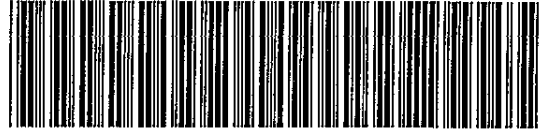

**ARTICLES OF INCORPORATION**  
of  
**Rogers Community Life Enrichment Center**

**ARTICLE I. NAME**

The official name of the corporation is Rogers Community Life Enrichment Center, Incorporated.

**ARTICLE II. PRINCIPAL OFFICE**

The principal place of business and mailing address of Rogers Community Life Enrichment Center, Incorporated is 1100 15<sup>th</sup> Street East, Bradenton, Florida 34208

**ARTICLE III. PURPOSE**

The purposes for which this corporation, a non-profit charitable corporation, is formed are: To provide educational support services, not limited to but, such as after school tutoring and school readiness skills to pre-school and school age children; To provide literacy and job preparatory skills, such as General Equivalency Diploma (G.E.D.) preparation, American College Test (ACT) and Scholastic Aptitude Test (SAT) preparatory courses, interviewing training, resume writing, mentoring and English for Speakers of Other Languages (ESOL) high school age students and adults and to engage in any other lawful activity which may hereafter be authorized from time to time by the Board of Directors; provided however, that the purposes for which the corporation is formed shall at all times be consistent with Section 501 (c)(3) of the Internal Revenue Code of 1986.

**ARTICLE IV. MANNER OF ELECTION**

The initial Board of Directors of the corporation shall be volunteers and shall serve until the first organizational meeting of the Board of Directors. The number of directors and the method of selecting directors, shall be fixed by the Bylaws of this corporation, provided that the initial directors shall be five in number.
