Articles of Amendment to Articles of Incorporation of Eastside Hope, Inc.

The corporation hereby adopts the following additional articles to its originally filed Articles of Incorporation:

Article VI

No part of the net earnings of the organization shall insure to the benefit of, or be distributable to its members, trustees, officers or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose clause hereof.

Article VII

No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distributions of statements) any political campaign on behalf of any candidate for public office.

Article VII

Notwithstanding any other provisions of this document, the organization shall not carry on any other activities not permitted to be carried on (a) by an organization exempt from federal income tax under Section 501(C)(3) of the Internal Revenue Code or (b) by an organization, contributions to which are deductible under sections 170(c)(2) of the Internal Revenue Code.

Article VIII

Upon the dissolution of the corporation, assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, to organizations which have received exempt statues under section 501(c)(3), or shall be distributed to the federal government, or to a state or local government, for public purpose.
