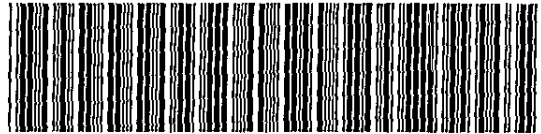

ARTICLE VIII. NOT FOR PROFIT CORPORATION


