<u> Amend-Article III - Purpose</u>

A. This Corporation is organized and operated as exclusively charitable and educational within the meaning of Section 501 (c)(3) of the Internal Revenue Code 1986 or the corresponding provision of any future United States Internal Revenue Law. The purpose of this Non-Profit Teaching Corporation is to serve poor and disadvantaged families and individuals through charitable and educational programs in order to bring positive change through a life of self-sufficiency and stability.
