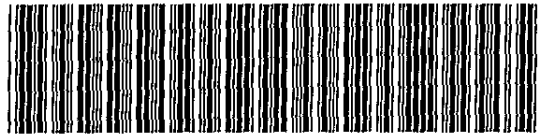

**ARTICLES OF INCORPORATION
OF
Recycle Services for Domestic Violence, Inc.**

The undersigned, acting as incorporators of a corporation pursuant to Chapter 617, Florida Statutes, adopt the following Articles of Incorporation:

Article I: Name

The name of the corporation shall be: RECYCLE SERVICES FOR DOMESTIC VIOLENCE, INC.

Article II: Principal Place of Business

The principal place of business and the mailing address of this corporation shall be: 109 Seaclusion Drive, Panama City Beach, FL 32413. The mailing address of the principal office of the corporation in this state is the same.

Article III: Purposes

The specific purposes for which the corporation is organized are: exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations under 501 (c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, and primarily for collecting and distributing household goods, furniture, personal items, and other supplies and support to victims of domestic violence and their families
