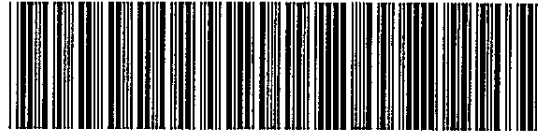

Cont. Article III Purpose
