AMENDMENT TO ARTICLES OF INCORPORATION

To Whom It May Concern:

THE LOVE IN ACTION CENTER, INC., having corporation number N03000006145 amends the following sections of its Articles to reflect the following updates:

ARTICLE IV (Purposes and Powers) insert after the word economic. (line 2): This organization is organized exclusively for charitable purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code.
