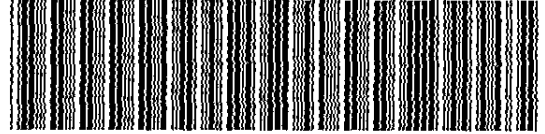

**ARTICLES OF INCORPORATION**  
**In Compliance with Chapter 617, F.S., (Not for Profit)**

The undersigned incorporators for the purpose of forming a corporation under the Florida not for profit corporation act, Hereby adopts(s) the following articles of incorporation.

**ARTICLE I**

**SEC 1 - NAME**

The name of this organization shall be the HELPING HANDS ORGANIZATION OF DELRAY BEACH INC.

**SEC 2 - DURATION**

The period of duration of this corporation shall be perpetual. The fiscal year shall begin August 1<sup>st</sup> and end July 31<sup>st</sup> of the following year.

**ARTICLE II PRINCIPAL OFFICE**

The principal place of business and mailing address of this corporation shall be: 109 SE 2<sup>nd</sup> Street, Delray Beach, FL 33444

**ARTICLES III PURPOSES**

H.H.O.D.B.I. is a non-profit organization created to: improve spiritual life and individual well being; encourage agricultural development; promote literacy and vocational skills programs; provide humanitarian assistance to the impoverished; develop community based health care systems and establish a variety of programs as needed to promote self-sufficiency and autonomy.

**ARTICLE IV MANNER OF ELECTION**

The manner in which the directors are elected or appointed is as follows: the Founders shall nominate all directors and officers.

**ARTICLE V INITIAL DIRECTORS/OFFICERS**

**ARTICLE VI INITIAL REGISTERED AGENT AND STREET ADDRESS**

**ARTICLE VII INCORPORATORS**

**Section 1.**

The governing body of this organization shall be its founders and the appointed board members. Board members can be nominated for a term of two (2) years and can be re-appointed according to the manner set forth in the bylaws of this corporation.

**Section 2.**

Except for the initial Board of Directors, which consists of the founders, the number of directors shall be no less than three (3) and not more than (7). The officers of this corporation shall consist of the following: A chairman, treasurer and a secretary. These offices shall be elected, or appointed by the founders and hold office as shall be prescribed in the bylaws of the corporation.

**ARTICLE VIII AMENDMENT AND BYLAWS**

The Articles of Incorporation may be amended by the manner set forth in the bylaws and the founding members to include or add any changes which, the Board of Directors and two of the founding members at any regular or specifically called for that purpose. The proposed action shall be made available at least ten (10) business days (excluding days) prior to the scheduled meeting of the Board of Directors.

The bylaws of this corporation may be amended or altered by two thirds (2/3) majority vote of the voting members for the Board and two of the founding members at any regular or specifically called for that purpose. The proposed action shall be made available at least ten (10) business days (excluding days) prior to the scheduled meeting of the Board of Directors.

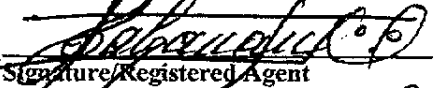
**ARTICLE IX IDEMNIFICATION**

The Corporation shall indemnify any of its officers, directors, or employee or any former officer, director or employee of the corporation to the full extend permitted by and set forth in the Florida General Corporation Act.

**ARTICLE X DEDICATION OF ASSETS**

The corporation shall dedicate all assets, which it may acquire to the charitable purpose set forth in Article III hereof. In the event that the corporation shall dissolve or otherwise terminate its corporate existence, subject to provisions of Chapters 607-617, Florida Statutes, the corporation shall distribute all its existing assets to one or more organizations which themselves are exempt as organizations described in Section 501 © (3) 170 © (2) of the Internal Revenue Code of 1954 or corresponding sections of any prior or future law, or to the Federal Government or to a state or local government for exclusive public purpose.

Having been named as registered agent to accept service of process for the above stated corporation at the place designated in this certificate, I am familiar with and accept the appointment as registered agent and agree to act in this capacity.

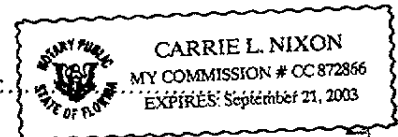
