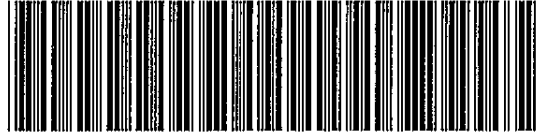

**Article IV Manner of Election**

**The manner in which directors are elected shall be as stated in the bylaws.**

## **Jackie Porter Ministries, Inc.**

The purpose or purposes for which this Corporation is formed are as follows. The Corporation is organized exclusively for charitable, religious and educational purposes, the making of distributions to organizations that qualify as exempt organizations under Section 501(c) (3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).

No part of the net earning of the Corporation shall inure to the benefit, or be distributable to its members, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance to its purposes. To establish and maintain an evangelistic association to spread the gospel of Jesus Christ throughout the world.

To provide a non-denominational ministry dedicated to the furthering of the Kingdom of God through conferences (seminars), radio and by way of any media necessary.

To print, distribute magazines and other literature in connection with the purpose of this ministry; to sell record and reproduce tapes, radio programs in connection with the purpose of this ministry.

In the event of dissolution, the Board of Directors shall, after paying or making provisions for the payment of all liabilities of the Corporation, dispose of all remaining assets and property of the Corporation exclusively for the purposes of the Corporation in such manner, or to such organization or organizations organized and operated exclusively for religious purposes as shall at the time qualify as an exempt organization or organizations under Section 501(c) (3) of the Internal Revenue Code of 1986 (or the corresponding provisions of any subsequent United States Internal Revenue Law, as the Board of Directors shall determine, or to another organization to be used in such manner as in the judgment of the home office of the Corporation, will best accomplish the general purposes for which this Corporation was formed.
