ARTICLES OF INCORPORATION
OF
BREAD OF LIFE EVANGELISTIC ASSOCIATION, INC.

The undersigned person, pursuant to Chapter 617 of the Florida Statutes, hereby executes the following articles of incorporation as follows:

ONE

The name of the corporation is Bread of Life Evangelistic Association, Inc.

TWO

The principal place of business and mailing address of this corporation is 972 Tarpon Avenue, Sebastian, Florida 32958.

THREE

The purpose for which the corporation is organized are:

1. To act as an educational, charitable and religious educational and literary purposes, including, for such purposes, the making of distributions to organizations under section 501 (c)(3) of the Internal Revenue Code of 1986 (or the corresponding provision of any future United States Internal Revenue Law).
2. To service as a para-church ministry that ministers across denominational lines and conducts an evangelistic, teaching, counseling and worship ministry. To serve the church and the unchurched in presenting the Gospel of Jesus Christ in the US and overseas through evangelistic crusades, teaching seminars and missionary outreaches.

FOUR

The directors of the corporation shall be elected as follows:

New directors shall be elected by the initial members of the board of directors in accordance with the provisions of the By-Laws. The directors shall serve for a period of two years; and they can relinquish their directorship only by resignation. Directors will elect their successors.

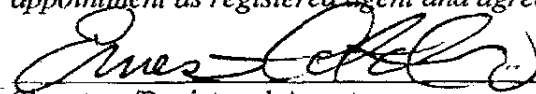

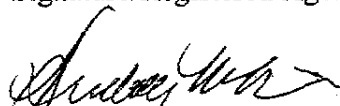
