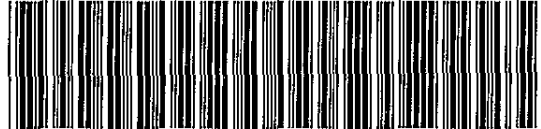

ARTICLES OF INCORPORATION

I, the undersigned natural person of the age of eighteen (18) years or more, acting as incorporator of Ted M. Corley Ministries, Inc. (the "Corporation"), a corporation organized under the Florida Not For Profit Corporation Act, do hereby adopt the following Articles of Incorporation for such Corporation.

ARTICLE ONE

Name

The name of the corporation is Ted M. Corley Ministries, Inc..

ARTICLE TWO

Initial Principal Office

The street address of the initial principal office of the Corporation is 1547 Harbor Oaks Rd., Jacksonville, FL 32207 and the mailing address of the Corporation is 1547 Harbor Oaks Rd., Jacksonville, FL 32207.

ARTICLE THREE

Duration

The period of the Corporation's duration is perpetual, commencing on the date of filing of these Articles of Incorporation.

ARTICLE FOUR

Purposes

Section 4.01. The Corporation is organized as a not-for-profit corporation, exclusively for charitable, scientific, and educational purposes as defined in Section 501(c)(3) of the Internal Revenue Code. These activities shall include but not be limited to:

To establish a ministry in order to communicate through said ministry's designated representatives, the un-compromised Gospel of Jesus Christ and His reconciling love; to assist local churches in sharing that message of love with people everywhere through evangelistic endeavors and missionary enterprise; and to strengthen the fellowship of local congregations through the ministries of Bible teaching and preaching.

To do all things necessary and proper in disseminate, propagate and spread the work of god as found in His Holy book throughout these United States and the world including but not limited to conducting of religious Revivals and/or evangelistic activities in local churches, associations, and conventions.

The ministry will provide Bible conferences and seminars to local congregations, associations and conventions.

The ministry will provide leadership for retreat, conferences, solemn assemblies, and seminars in the area of evangelistic training and prayer. (Intercessory prayer and spiritual warfare).

The ministry will provide leadership training for local congregations, Baptist Associations, Conventions and Covenant Pastor groups on an ongoing basis. This part of the ministry will be known as InterLink (Linking Leaders: Heart to Heart, Spirit to Spirit, and Ministry to Ministry). It will consist of large group training seminars and small peer groups.

The ministry will be committed to providing ministry to Local, National and International Missions and Missionaries on an ongoing basis. (Bible teaching, Bible preaching, Seminars, and Leadership Training)

The ministry will develop, promote, and recruit, Pastors and Churches to engage in the ministry known as Adopt-A-Cop, an intercessory prayer ministry committed to praying for Police Officers and significant decreases in crime within a geographic region.

This cooperation will be operated and is to be maintained by donations, contributions, and any and all other forms of gifts and/or monetary gain incidental to the operation of any enterprise engaged in by this corporation authorized under its purposes and objects as enumerated herein.

It is specifically understood that this corporation may provide necessary funds, if available, for evangelistic and missionary enterprises for those in need of religious conversion, instruction, enlightenment and rehabilitation.

Section 4.02. Notwithstanding any other provision of these articles of incorporation:

a. No part of the net earnings of the Corporation shall inure to the benefit of any director of the Corporation, officer of the corporation, or any private individual (except that reasonable compensation may be paid for services rendered to or for the Corporation affecting one or more of its purposes); and no director, officer or any private individual shall be entitled to share in the distribution of any of the corporate assets on dissolution of the Corporation. No substantial part of the activities of the Corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene in (including the publication or distribution of statements) any political campaign on behalf of any candidate for public office.

b. The Corporation shall not conduct or carry on any activities not permitted to be conducted or carried on by an organization exempt from taxation under Section 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended, or by an organization, contributions to which are deductible under 170(c)((2) of the Internal Revenue Code and regulations as they now exist or as they may hereafter be amended.

c. Upon dissolution of the Corporation or the winding up of its affairs, the assets of the Corporation shall be distributed exclusively to charitable organizations which would then qualify under the provisions of Section 501(c)(3) of the Internal Revenue Code and its regulations as they now exist or as they may hereafter be amended.

d. The Corporation is organized pursuant to the Florida Not for Profit Corporation Act and does not contemplate pecuniary gain or profit and is organized for nonprofit purposes.

ARTICLE FIVE Membership

The Corporation shall have no voting members.

ARTICLE SIX Initial Registered Office and Agent

The street address of the initial registered office of the Corporation is 1547 Harbor Oaks Rd., Jacksonville, FL 32207 and the name of its initial registered agent is Ted M. Corley.

ARTICLE SEVEN Directors

The number of Directors constituting the initial Board of Directors of the corporation is three (3), the method of appointment of Directors shall be as provided in the bylaws. The names and addresses of those people who are to serve as the initial Directors are:

ARTICLE EIGHT Indemnification of Directors and Officers

Each Director and each officer or former Director or officer of the Corporation may be indemnified and may be advanced reasonable expenses by the Corporation against liabilities imposed upon him or her and expenses reasonably incurred by him or her in connection with any claim against him or her, or any action, suit or proceeding to which he or she may be a party by reason of his or her being, or having been, such Director or officer and against such sum as independent counsel selected by the Directors shall deem reasonable payment made in settlement of any such claim, action, suit or proceeding primarily with the view of avoiding expenses of litigation; provided, however, that no Director or officer shall be indemnified (a) with respect to matters as to which he or she shall be adjudged in such action, suit or proceeding to be liable for negligence or misconduct in performance of duty, (b) with respect to any matters which shall be settled by the payment of sums which independent counsel selected by the Directors shall not deem reasonable

payment made primarily with a view to avoiding expense of litigation, or (c) with respect to matters for which such indemnification would be against public policy. Such rights of indemnification shall be in addition to any other rights to which Directors or officers may be entitled under any bylaw, agreement, corporate resolution, vote of Directors or otherwise. The Corporation shall have the power to purchase or maintain at its cost and expense insurance on behalf of such persons to the fullest extent permitted by this Article and applicable state law.

ARTICLE NINE
Limitation on Scope of Liability

No Director shall be liable to the Corporation for monetary damages for an act or omission in the Director's capacity as a Director of the corporation, except and only for the following:


- a. A breach of the Director's duty of loyalty to the Corporation;
- b. An act or omission not in good faith by the Director or an act or omission that involves intentional misconduct or knowing violation of the law by the Director;
- c. A transaction from which the Director gained any improper benefit whether or not such benefit resulted from an action taken within the scope of the Director's office; or
- d. An act or omission by the Director for which liability is expressly provided by statute.


