The undersigned, acting as incorporator of a non-profit corporation under the provisions of Florida Statutes, Chapter 617, does hereby adopt the following Articles of Incorporation:

ARTICLE I.

Name

The name of this Corporation (hereinafter called the "Association") shall be:

ARTICLE II.

Term of Existence

The duration of this association shall be perpetual.

ARTICLE IV.

Purposes

The general nature of the business or businesses to be transacted by this corporation, together with and in addition to the authority and powers conferred by the laws of the State of Florida, is to engage in dialoge and educational efforts to establish programs for consumer protection. No substantial part of the activities of the corporation shall be the carrying on of a propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these Articles, the corporation shall not carry on any other activities not permitted to be carried on by the Internal Revenue Code, or the corresponding section of any future federal tax code.


