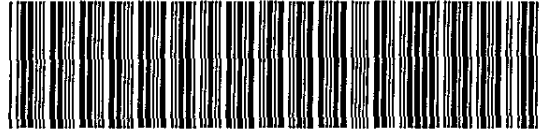

Articles Of Incorporation

In Compliance with Chapter 617, F.S., (Not for Profit)

Article I Name

The name of the corporation shall be: Sencond Chance Outreach INC.

Article II Principal Office

The principal place of busines of this Corporation shall be: 917 East Buchanan Ave.
Orlando, FL 32809. The principal Mailing address of this corporation shall be: P.O Box 590752
Orlando, FL 32859-0752

Article III Purpose

The purpose for which the corporation is organized is: to provide comprehensive charitable health service to people of color including; but not limited to; prevention, and education of HIV/AIDS, and prevention, and education. These charitable service include outreach and education, training programs, housing, transportation, referral, and counseling service including; but not limited to, moral and spiritual counseling, mentoring.

a) Said organizatoin is organized exclusively for charitable, religious, education, and scientific purpose, including, for such purposes, the making of distributions to organizations that qualify as exempt organization inder section 501(c)(3) of the International Revenue Code, or corresponding section of any future federal tax code.

b) No part of the net earings of the organization shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the organization shall be authorized and empowered to pay reasonable compensation for service rendered and to make payments and distributions in furtherance of the purposes set forth in the purpose cause hereof. No substantial part of the activities of the organization shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the organization shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of any candidate for public office.

c) Not withstandind any other provisoion oftheis document, the organization shall not carry on any other activites not permitted to be carried on (a) by an organization exempt form federal income tax under section 501(c)(3) of International Revenue Code, or corresponding section of any federal tax code, or (b) by an organization, contributions to which are deductible inder section 170 (c)(2) of the International Revenue Code, or corresponding section of any future federal tax code.

d) Upon the dissolution of the organization, assets shall be distributed for one or more exempt purpose within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future tax code, or shall distributed to the federal government, or to a state local government, for public purpose. Any such assets not disposed of shall be disposed of by the Court of Common Pleas of the county in which the principal office of the organization is the located, exclusively for such purpose or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.

e) The President, Vice-President, Secretary, and Treasurer shall be the signers on all corporation

bank accounts; with two signatures being required to sign checks on all checking accounts.

Article IV Manner Of Election

The initial members of the Board of Directors and Officers were appointed and accepted their positions by mutual and unanimous decision, Members of the Board of Directors and Officers will be elected by three-fourth majority vote of the current Officers. The term of membership for the Officers will be Lifetime; but Officers can resign at any time. The general member of the Board of Directors can be removed by unanimous decisions of the Officers. All nominees to the Board of Directors will be submitted by the Officers.

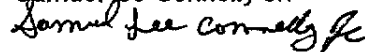
