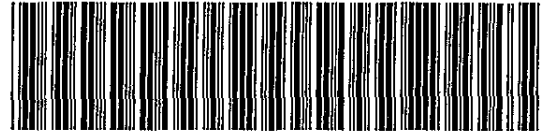

ARTICLES OF INCORPORATION OF RHETORIC, INC.

In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be:
RHETORIC, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be:

ARTICLE III PURPOSE

This corporation is established to provide musical enrichment to the community through concerts, education and outreach. It will strengthen the availability of entertainment to the general public, and educate current and future audiences.

This corporation is organized exclusively for charitable and musical purposes, including for such purposes, the making of distributions to organizations that qualify under section 501(c)(3) of the Internal Revenue Code, or any corresponding section of any future federal tax code. No proceeds of the corporation will enrich any individual, except that reasonable compensation may be paid for services to the corporation. If the corporation is dissolved, any assets remaining will be distributed to another corporation serving a similar purpose and qualifying as a tax-exempt, charitable organization under the provisions of the 501(c)(3) of the Internal Revenue Service.

ARTICLE IV MANNER OF ELECTION

Directors will be appointed after documented interest is expressed. The Board of Directors will vote. A 2/3 majority is required for appointment.

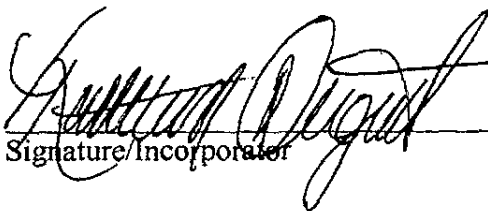
