ARTICLES OF INCORPORATION OF RHETORIC, INC. TALL ALLASSE OF STATE TALLAHASSEE, FLORIDA In Compliance with Chapter 617, F.S., (Not for Profit)

ARTICLE I NAME

The name of the corporation shall be: RHETORIC, Inc.

ARTICLE II PRINCIPAL OFFICE

The principal place of business and mailing address of this corporation shall be: 6495 Taylor Road Naples, Florida 34109

ARTICLE III **PURPOSE**

This corporation is established to provide musical enrichment to the community through concerts, education and outreach. It will strengthen the availability of entertainment to the general public, and educate current and future audiences.
