Articles of Incorporation of

I, CLIFFORD B. HARK, the undersigned incorporator of this corporation under Section 617.0202, Florida Statutes, as amended, do hereby form this not for profit corporation and adopt the following Articles of Incorporation.

ARTICLE I - NAME

The name of this corporation is SpiritSupportGroup.org, Inc.

ARTICLE II - PURPOSE AND NATURE OF BUSINESS

The purpose of this corporation and general nature of the business to be conducted is to provide an on-line support community for individuals experiencing physical, mental and emotional challenges and illnesses, who want to share their thoughts and feelings during those times with other like-minded individuals in an online forum.

ARTICLE III - DURATION OF CORPORATION

This corporation is to have perpetual existence commencing on the date of execution and acknowledgment of these Articles of Incorporation.

ARTICLE IV - DIRECTORS

The initial number of directors of this corporation shall be three (3). The number of directors may either be increased or decreased from time to time by vote of the members in conformity with the By-Laws of the Corporation, but shall never be less than three (3). The method in which the Directors shall be appointed or elected shall be set forth in the Corporation's By-Laws.

ARTICLE V - INITIAL BOARD OF DIRECTORS

The corporation shall have the further right and power to:

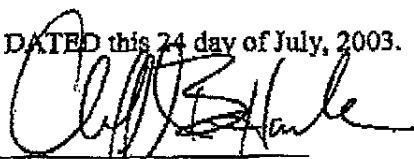
A. Both members and directors shall have power, if the by-laws so provide, to hold their respective meetings, and to have one or more offices within or without the State of Florida, and to keep the books of this corporation (subject to the provisions of the statutes of the State of Florida) outside the State of Florida, at such places as may from time to time be designated by the Board of Directors.

D. The corporation reserves the right to amend, alter, change or repeal any provision contained in this Certificate of Incorporation, in the manner now or hereafter prescribed by statute, and all rights conferred upon stockholders herein are granted subject to this reservation.
