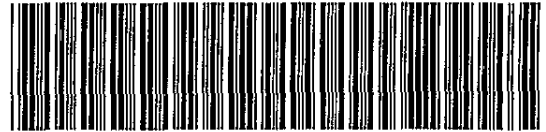

ARTICLES OF INCORPORATION
OF
Jessica Eva Moore Center, Inc.

ARTICLE I – NAME

The name of the corporation is JESSICA EVA MOORE CENTER, INC., a Florida corporation not for profit.

ARTICLE II –PRINCIPAL OFFICE

ARTICLE III – PURPOSES

The specific purposes for which this corporation is organized are:

- To plan, organize, implement and evaluate programs and activities for general community development, and to promote health and social services for disadvantaged individuals and families.

The corporation shall issue no stock. No part of the net earnings of this corporation shall inure to the benefit of or be distributed to its members, directors, officers or other private persons except that this corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in this article. No substantial part of the activities of this corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation. This corporation shall not participate or intervene in any political campaign on behalf of any candidate for public office, including the publishing or distribution of statements. Notwithstanding any other provision of these articles, this corporation shall not carry on any other activities not permitted to be carried on by a corporation exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code of 1986 or the corresponding provision of any future United States Internal Revenue Law. On dissolution of this corporation the board of directors shall dispose of all the assets of this corporation exclusively to a Florida not for profit corporation, organized and operated exclusively for charitable, educational, religious or scientific purposes and which shall at the time qualify as exempt under Section 501 (c) (3) of the Internal Revenue Code of 1954 or the corresponding provisions of any future United States Internal Revenue Law, after paying or making provisions for the payment of all liabilities of this corporation. Any assets not so disposed of shall be disposed of by a court of competent jurisdiction in the county where the principal office of this corporation is then located exclusively for the purposes or to the organizations that the court determines are organized and operated exclusively for charitable, educational, religious or scientific purposes.

ARTICLE IV – MANNER OF ELECTION OF OFFICERS

Directors are elected to this corporation as described in the bylaws.

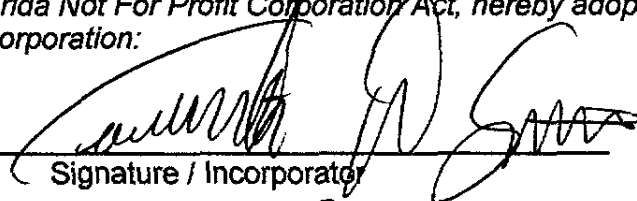
