AMENDMENT TO THE

ARTICLES OF INCORPORATION

OF

MERRITT ISLAND CERT, INC.

The following articles are to amend the ARTICLES OF INCORPORATION OF MERRITT ISLAND CERT, INC. filed on July 23, 2003 on document number N03000006472.

Replace the current Article III with the following:

Article III - Purpose

The corporation is organized exclusively for charitable, religious, educational and, scientific purposes, including for such purposes, the making of distributions to organizations under section 501 (c)(3) of the Internal Revenue Code (or the corresponding section of any future Federal tax code). Its main function is to provide an organization of citizens within the Merritt Island and Cocoa Beach areas, trained and coordinated with other Community Emergency Response Teams ("CERT") by the Brevard Office of Emergency Management for the primary purpose of activating in the aftermath of a disaster to help save lives as auxiliary responders.

Replace the current Article X with the following:

Article X

Upon dissolution of this corporation any remaining assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future Federal tax code, or shall be distributed to the Federal government or to a state or local government for a public purpose as selected by the Board of Directors at the time of dissolution.

Add the following Article:

Article XIII - Activities

No part of the net earnings of the corporation shall inure to the benefit of, or be distributed to its members, trustees, directors, officers or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of section 501(c)(3) purposes. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office.

Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from Federal income tax under section 501(c)(3) of the Internal Revenue Code (or corresponding section of any future Federal tax code) or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code (or corresponding section of any future Federal tax code).
