E. Changes and additions to Articles:

Article III - Purpose (Change paragraph 1 to read):

The purpose of the Corporation is to provide an organization of volunteer citizens within the Merritt Island area and the unincorporated areas between Cocoa and Titusville, Florida, trained and coordinated with other Community Emergency Response Teams ("CERT") by a designated, official Brevard County Government Department for the primary purpose of activating in the aftermath of a disaster to help save lives as auxiliary responders.

Article III - Purpose (Add paragraph 2 to read):

Said organization is organized exclusively for charitable, religious, educational, and scientific purposes, including, for such purposes, the making or distributions to organizations that qualify as exempt organizations under section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code.

Article X – Dissolution (Change paragraph 1 to read):

Upon the dissolution of the organization, assets shall be distributed for one or more exempt purposes within the meaning of section 501 (c) (3) of the Internal Revenue Code, or corresponding section of any future federal tax code, or shall be distributed to the federal government, or to a state or local government, for a public purpose. Any such assets not disposed of shall be disposed of by a Court of Competent Jurisdiction of the county in which the principal office of the organization is then located, exclusively for such purposes or to such organization or organizations, as said Court shall determine, which are organized and operated exclusively for such purposes.
