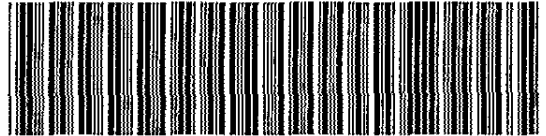

Stats., the undersigned incorporators, hereby make, subscribe, acknowledges and files with the Secretary of State of the State of Florida, these Articles of Incorporation for the purpose of forming a corporation for not-for-profit in accordance with the laws of the State of Florida.

**ARTICLE I NAME**

The name of the corporation shall be:

**ARTICLE II PRINCIPAL OFFICE**

The specific purpose(s) for which the corporation is organized are:
