The power to adopt, alter, amend or repeal the Bylaws of this corporation shall be vested solely in the Board of Directors of the Corporation.

NONSTOCK MEMBERSHIP CORPORATION

The corporation shall be organized as a nonstick membership corporation. Qualifications for members and manner of their admission to membership in the Corporation shall be as regulated by the Bylaws of Corporation.

ARTICLE IV.
MANNER OF ELECTION

A) The corporation shall possess and exercise all the powers and privileges granted by Chapter 607 and 617 of the Florida Statutes as they now exist or as they may be hereafter amended, or by any other law of Florida applicable in any manner to not for profit corporations limited only by the restrictions set forth in the Articles of Incorporations and in said Chapter 607 of the Florida Statutes.

B) No part of the net earnings of the Corporation shall inure to benefit of, or be distributable to its members, director, trustees, officers, or other private persons, except that the Corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purpose set forth in the Articles hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda or otherwise attempting to influence legislation, and the Corporation shall not participate in, or intervene (including the publishing or distribution of statement) any political campaign on behalf of in opposition to any candidate for public office. Notwithstanding any other of these Articles, the Corporation shall not carry on any other activities not permitted to be carried on (a) by a Corporation exempt from federal income tax under Section 501(c) (3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a Corporation, contributions to which are deductible under Sections 170 (c) (2) of Internal Revenue Code or the corresponding section of any future federal tax code.
