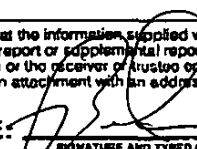

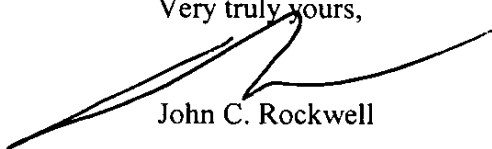
To Whom It May Concern:

Our office represents the above-referenced corporation (TCHOA). On October 7, 2005, we received the enclosed Notice of Dissolution or Revocation for failure to file an annual report for 2005.

On or around April 19, 2005, D'Assign Developments LLC sent for filing to the Florida Department of State an annual report form and check number 1233 in the amount of \$61.25 for the required annual report fee, which was cashed (see enclosed copy of cancelled check 1233). Apparently, the Florida Department of State sent a letter dated May 4, 2005 asking TCHOA to correct the filed annual report, but neither D'Assign Developments nor TCHOA received this letter.
