#### ARTICLES OF AMENDMENT

### OF THE ARTICLES OF INCORPORATION

### IRWIN AVENUE BUSINESS CONDOMINIUM ASSOCIATION, INC.

IRWIN AVENUE BUSINESS CONDOMINIUM ASSOCIATION, INC., (the "Association") pursuant to its Articles of Incorporation, By-Laws and the Declaration of Condominium of Irwin Avenue Business Condominiums (the "Declaration"), hereby amends its Articles of Incorporation (which are recorded in Official Records Book 5027, Page 2793; specifically page 2831, Public Records of Brevard County, Florida) pursuant to these Articles of Amendment as follows:

I. Article XIV is hereby added to the Articles of Incorporation as follows:

### ARTICLE XIV- ST. JOHN'S RIVER WATER MANAGEMENT DISTRICT PROVISIONS

Section 1. The Association shall operate, maintain and manage the surface water or stormwater management system(s) in a manner consistent with the St. John River Water Management District ("SJRWMD") permit no. 42-009-71528-1 requirements and applicable SJRWMD rules, and shall assist in the enforcement of the Declaration of Condominium of Irwin Avenue Business Condominiums which relate to the surface water or stormwater management system(s). Furthermore, the Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the surface water or stormwater management system(s). Furthermore, the Association shall levy and collect adequate assessments against members of the Association for the costs of maintenance and operation of the surface water or stormwater management system.

Section 2. Existence of the Association shall commence with the filing of these Articles of Incorporation with the Secretary of State, Tallahassee, Florida; and the Association shall exist in perpetuity. In the event of termination, dissolution or final liquidation of the Association, the responsibility for the operation and maintenance of the surface water or stormwater management system(s) must be transferred to and accepted by an entity which would comply with Section 40C-42.027, F.A.C., and be approved in writing by SJRWMD prior to such termination, dissolution or liquidation.

II. These Articles of Amendment were adopted as of the 13<sup>th</sup> day of May, 2010.
