ARTICLES OF INCORPORATION

The undersigned incorporator, for the purpose of forming a corporation under the Florida Business Corporation Act, hereby adopts the following Articles of Incorporation.

Article I. Name

The name of this corporation shall be J&K's Outreach Services For Women and Children In Need, Inc.

Article II. Principal Place of Business

Article III. Purpose of Business

The specific purpose of this not-for profit exempted organization shall be:

- 1). To provide temporary shelter to women and children in need who may have left their home due to abusive situations;
- 2). To provide services such as food, clothing, housing to the economically disadvantaged.
- 3). To provide aide, respite housing, clothing and protection to those individuals finding themselves suddenly within the named above.
- 4). To provide educational awareness, advocate services and physical, emotional and spiritual support to the less fortune person(s).
- 5). These services shall including feeding the hungry, providing a safe haven to those individuals who are economically deprived. Re-orientation of women back into society who are released from prison by way of on the job training, offering an opportunity to acquire a high school diploma, teaching them proper morals and conduct.
- 6). Services shall include and not be limited to an individuals race, creed, color, religious nor national origin, but shall include all people according to their various needs. And these services shall include individuals who are considered handicapped.

Article IV. Manner of Election of Directors

The manner in which the directors are elected or appointed shall be elected by the Charter Members of the Regular Election, and shall take office immediately. Therefore; all officers/directors shall be elected by the majority association membership

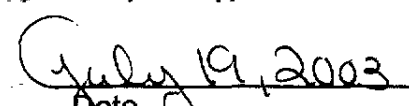
Article VIII. Amendments

These elections may be altered or amended in the following ways:

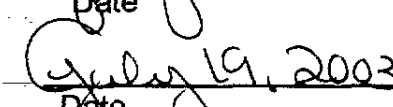
- 1). The Amendment shall be read at a regular called meeting of the Board and voted on at the next regular meeting of the Board.
