Pursuant to the provisions of section 617.1006, Florida Statutes, this *Florida Not For Profit Corporation* adopts the following amendments to its Articles of Incorporation:

**Amendment Article III**

People Care Center, Inc. is organized exclusively for charitable and educational purposes with particular emphasis on providing counseling, and education to HIV/AIDS individuals and their families. Promote community participation and involvement in HIV/AIDS prevention services and activities. Strengthen local collaboration efforts between public and private organizations in the fight against HIV disease.

Upon the dissolution of People Care Center, Inc., assets shall be distributed for one or more exempt purposes within the meaning of section 501(c)(3) of the Internal Revenue Code, or corresponding section of any future federal tax code for a public purpose.

The date of adoption of the amendment is January 19, 2004.

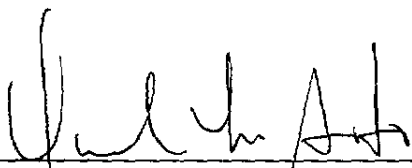
